#### *Adult & Minor Amateur Athletic Waiver and Release of Liability*

In consideration of being allowed to participate in any way in the Pennsylvania Shotokan Karate Club (P.S.K.C.) /USA Elite Training Camp (USA E.T.C.) athletics/sports program, and related events and activities, the undersigned:

I. Agrees that prior to participating, they (if under 18) Parents or Guardian, will inspect the facilities and equipment to be used, and if the participant and/or Parent or Guardian, believes anything is unsafe, they will immediately advise their coach or supervisor or P.S.K.C./USA E.T.C. personnel of such condition(s) and refuse to participate.

II. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inaction's or negligence but the action's or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.

Release, waive, discharge and covenant not to sue the P.S.K.C./USA E.T.C. instructors, its officers, its affiliated clubs, regional sports organizations, their respective administrators, directors, agents, coaches and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of the premises used to conduct the event, all of which are herein after referred to as "releases" from any and all liability to each of the undersigned, his or heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
