- Registration Fee is \$100 per division.
- Participants must compete in either Elite Advanced Division or regular Advanced Divisions. Participants cannot compete in both.
- Elite Divisions must have a minimum of 10 participants to qualify for the \$1,000 cash prize. If division has less than 10 participants, the cash prize will be equal to the number of competitiors, i.e. 6 participants = \$600; 8 participants = \$800, etc.
- Weight classes may be combined in order to reach the minimum number of competitors for the \$1,000 cash prize only if all participants and coaches agree.
- Participants must be age 16 or older for Kata and 18 or older for Kumite.

In consideration of being allowed to participate in any way in the Virginia Martial Arts Center and Brian Hobson School of Karate athletics/sports program, and related events and activities, the undersigned:

1. Agrees that prior to participating, the (if under 18) Parent or Guardian, will inspect the facilities and equipment to be used, and if the participant and/or Parent or Guardian, believes anything is unsafe, they will immediately advise their coach or supervisor or Mid-Atlantic Karate Championships personnel of such condition(s) and refuse to participate.

2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.

3. Release, waive, discharge and covenant not to sue Virginia Martial Arts Center, USA Karate, Event Venue, City and County of the Event, its officers, its affiliated clubs, regional sports organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used to conduct the event, all of whichare hereinafter referred to as "releasees" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
